

BEDFORD AT LAKE CATHERINE HOA, INC. LEASE APPLICATION INSTRUCTIONS

To: Bedford @ Lake Catherine Owner / Realtor

The lease of any property in Bedford at Lake Catherine by an owner is subject to prior approval of the Association. Owners HOA assessments must be current and all fines must be paid in full prior to any lease approval. The Association shall review the proposed **Lease Application** within ten (10) business days of receipt of the required information, documents and fees. A Certificate will then be issued indicating the Association's approval of the transaction. If a Certificate of Approval of the lease is not provided by the Association within ten (10) business days it shall be deemed a disapproval of the lease.

In order that your Certificate of Approval is processed in a timely manner, please make sure you have completed and enclosed the following documents:

- <u>LEASE APPLICATION</u> All prospective tenants 18 years and older must complete the application (application fees apply for each adult regardless of marital status). All tenants are applicants whether or not they are on the lease agreement or contract.
- Copy of LEASE AGREEMENT OR CONTRACT (term no less than 12 months and no more than 24 months)
- PROSPECTIVE OWNER AND LEASE ACKNOWLEDGEMENT FORM
- **BACKGROUND CHECK AUTHORIZATION** This form must be completed for each applicant and occupants 18 years or older.
- Attach a \$100.00 non-refundable check for the <u>APPLICATION FEE</u> payable to "Bedford at Lake Catherine HOA" (certified bank check or money order only).
- In addition, attach a separate \$100.00 non-refundable check for the <u>BACKGROUND AND CREDIT CHECK FEE</u> for <u>each</u> prospective tenant and occupants 18 years or older payable to "Bedford at Lake Catherine HOA" (certified bank check or money order only).
- A damage <u>SECURITY DEPOSIT</u> in the amount of one quarterly assessment for each tenant 18 years or older is required from the unit owner, payable to "Bedford at Lake Catherine HOA". Deposit shall be held in an escrow account maintained by the Association to pay for any damage to the Common Area property or other portions of the property resulting from acts or omissions of tenants. Deposit without interest will be refunded at the end of lease term if no damage has been caused by tenant(s) or their guests during the lease period.
- **PROOF OF IDENTITY** A **legible** photocopy of a valid driver's license or other state or federal photo ID for each applicant and occupants 18 years and older.
- Pets Please provide current **TAG INFORMATION AND/OR VETERINARIAN CERTIFICATE FOR EACH PET**. No more than two (2) pets permitted in a rental. No animal may be kept in the unit, which in the judgment of the Board, results in a nuisance or is obnoxious to the residents in the vicinity. No owner shall be permitted to maintain in his or her unit a bull terrier (pit bull) or any dog or dogs of mean or of violent temperament or otherwise evidencing such temperament.
